What information do we collect?

We collect information from you when you visit our website, place an order or fill out a form. When ordering from us, you may be asked to enter your: name, company name (if applicable), e-mail address, mailing address, billing address, phone number and credit card information. Other information may be requested, as required, to complete the transaction. When contacting us, you may be asked your: name, company name (if applicable), job title, e-mail address, mailing address and nature of inquiry. You may, visit our site anonymously, providing you agree with Zestar Corporation's Terms and Conditions.

What other information is collected?

Like most other websites, we collect log files from site visitors. This data does not identify you personally, rather it contains details pertaining to our domain. Domain information collected includes typical web statistics such as Total Sessions, Total Hits, Total Pageviews, Total Hits and Total Bytes Transferred. It also includes data on external web pages that brought traffic to our site, your computer's operating system and identity of the networks where the site visitors came from. We may also use cookies. A cookie is a small amount of data on the hard drive of your computer stored by your browser that allows Zestar Corporation to track your session on our Website by storing your preferences. An example of cookie usage would be remembering and processing items in your shopping cart. Internet web browsers may be set not to accept cookies. However, disabling cookies in your browser may affect your ability to interact with our site.

How do we use the information we obtain?

Credit card information is securely transmitted to Zestar Corporation's vendor for processing payments. Companies contractually working with Zestar Corporation for fulfilling orders, providing technical services, etc., may have access to personal information solely for the purpose of performing such functions.
